- 1. Summary of Changes: P.S. 2000.02, Chapter 10770, has been revised to reflect the Prompt Payment Act Amendments of 1988. The amendment to this act:
 - a. Eliminates grace periods;
 - b. Requires acceptance of goods of and services within seven days;
 - d. Permits agencies to make payments up to seven days before the due date or earlier on a case-by-case basis;
 - e. Requires payment of specified types of construction contract bills within 14 days; and
 - f. Requires payment of additional penalties for non-payment of late payment penalties.
