Hiring and Staffing
FY 2021 First Quarter Report**

Legislative Summary

The Joint Explanatory Statement accompanying the Consolidated Appropriations Act, 2021 (P.L. 116-260), states, “*BOP shall continue to submit quarterly reports on inmate-to-correctional officer ratio as required by the explanatory statement accompanying Public Law 116-93, and to publish these reports on the BOP website. To the extent BOP does not currently record staffing by shift, it is directed to begin doing so and include such metrics in this report by the end of fiscal year 2021. Separately, BOP shall submit a report to the Committees regarding any incident involving the use of deadly force at an institution with a staffing ratio greater than 15:1, explaining any role staffing levels may have played in the incident, and describing a detailed plan to prevent recurrence of such incidents.*”

Further, the House Report (H. Rept. 116-455) accompanying the Consolidated Appropriations Act, 2021 (P.L. 116-260), states, “*The Committee directs BOP to continue to submit quarterly reports on the inmate-to-correctional officer ratio at each facility, using the OPM definition of a corrections officer, broken out by security level and shift, including confirmation that at least two correctional officers are on duty for each shift at BOP facilities that house high security inmates, as specified in the fiscal year 2020 Appropriations Act.*”

The following information is provided to address the Committee’s request for inmate-to-correctional officer ratios for the First Quarter of FY 2021.

Report

During the first quarter of FY 2021, there were two institutions with an inmate-to-correctional officer ratio greater than 15:1. Please see separate explanation below the table of inmate-to-correctional officer ratios.

The BOP has made the hiring of additional Correctional Officers a system-wide priority and combined with a downward trend in the inmate population, the BOP’s progress in improving the inmate-to-correctional officer ratio at institutions is already evident. At the end of the fourth quarter of FY 2020, there was one institution with an inmate-to-correctional officer ratio greater than 15:1. As of December 31, 2020, that same institution has improved its staffing ratio: Federal Prison Camp (FPC) Bryan’s ratio decreased from 17.2:1 to 15.7:1. FPC Bryan had a staffing ratio greater than 15:1 at the end of the first quarter; however, the institution continues to strive to lower the ratio to be closer to the 15:1 or lower.

One institution has a staffing ratio greater than 15:1 at the end of the first quarter of FY 2021 that did not at the end of the fourth quarter of FY 2020, but the ratio is slightly greater than 15:1: Federal Correctional Institution (FCI) Seagoville with staffing ratio of 15.2:1.

As requested, this report provides staffing by shift on the final pages of this report. Many of the by-shift staffing ratios are higher than the institution-level ratios, due to how the different ratios are calculated and the critical need to staff more Correctional Officers during peak operational times.

The overall inmate-to-correctional officer ratio is calculated using the number of on-board Correctional Officers and the number of inmates at the institution. For example, for FPC Alderson, there were 46 Correctional Officers on-board and 527 inmates as of December 31, 2020, producing the 11.5:1 ratio.

A search of all Report of Incidents revealed there was no use of deadly force from October 1, 2020, to December 31, 2020.

**As of December 19, 2020, there were 118 Camp Inmates at FCI Estill. Only Camp inmates have returned to FCI Estill. All other inmates were relocated to other BOP facilities due to damages sustained during a tornado in April 2020. Repairs at FCI Estill are ongoing.

Facilities with Inmate-to-Correctional Officer Ratio Over 15:1

As required, below is an accounting of institutions with a staffing ratio greater than 15:1 during the first quarter of FY 2021. For the institutions listed below, the BOP continually recruits and is actively hiring throughout the BOP. The BOP has offered a 5% retention incentive to staff eligible to retire in an effort to retain staff. Additionally, the BOP offers recruitment and relocation incentives and has contracted with Accenture to market and brand the BOP in an effort to attract more candidates.

- The Federal Prison Camp (FPC) Bryan, Texas, a minimum security institution, was staffed at 15.7:1.
- The Federal Correctional Institution (FCI) Seagoville, Texas, a medium security institution, was staffed at 15.2:1

Inmate-to-Correctional Officer Ratio by Shift

The following information is provided to address the Committee's request to provide information on Staffing by Shift.

The system-wide inmate-to-Correctional Officer ratio of 8:1 has a very different meaning in an operational context. Given daily shifts, the number of staff present in an institution varies based on the time of day and the day of the week.

The BOP has six total shifts, including three Weekday and three Weekend shifts. Morning Watch is from 12 a.m. to 8 a.m., Day Watch is from 8 a.m. to 4 p.m., and Evening Watch is from 4 p.m. to 12 a.m.

Below is the listing of Correctional Officer to Inmate ratio by each watch (or shift). Each number indicates an X:1 inmate-to-Correctional Officer ratio for that shift. This information is based on the Correctional Officer Roster as of the end of the first quarter of FY 2021.
