Audit Findings

Audit Narrative

Pre-Audit Preparation

Prior to the on-site visit, a representative from the External Auditing Branch, Program Review Division, Federal Bureau of Prisons (BOP), conducted an on-site "pre-audit" of the facility to ensure PREA compliance. BOP Central Office staff are extremely knowledgeable of the PREA and serve as the agency liaisons with each facility for all PREA audits. At the direction of the representative, all policies and supportive documentation were provided to the auditor for review, prior to the on-site visit. Policies and documentation were provided such as Program Statements (PS), Institution Supplements (IS), other forms and memos. Program Statements are agency-wide governing policies developed by the BOP and Institution Supplements stipulate institution specific policies. The results of the pre-audit were discussed with the auditor prior to the on-site visit.

Entrance Briefing and Tour (On-site Audit)-First Day

The on-site PREA (Prison Rape Elimination Act) compliance audit of the Federal Correctional Complex (FCC), located in Beaumont, Texas, was conducted May 22-24, 2018 by The Nakamoto Group Inc. certified PREA auditors James L. Roland, Jr. (Lead) and Sonja Love-Smith. This is the second PREA audit for this facility. Upon arrival at the facility, an in-briefing meeting was held with the Complex Warden; Warden, Medium Security Institution; Warden, Low Security Institution; Associate Warden/PREA Compliance Manager; four other Associate Wardens; Camp Administrator; Chief of Psychology Services; Sr. Operational Manager; two Captains; several Department Heads; one Management Analyst from the BOP Central Office; two American Correctional Association (ACA) Auditors; and a representative from the BOP Program Review Division. The standards used for this audit became effective August 20, 2012. The lead auditor discussed the information contained in the Pre-Audit Questionnaire with the Institution PREA Compliance Manager (IPCM) and the Chief of Psychology Services. The National PREA Coordinator and National PREA Contract Administrator for the BOP were previously interviewed telephonically. As part of the audit, a review of all agency and local facility PREA policies was conducted, as well as a tour of the facility. During the on-site tour, the auditor reviewed PREA related documentation and materials located on bulletin boards and entries made in electronic logs. The auditor tested telephones and other electronic media which provide offender access to outside independent advocacy reporting capabilities. The auditor assessed camera surveillance, physical supervision and electronic monitoring

capabilities. During the on-site tour, the auditor discussed the practical implementation of the standards with housing unit officers, intake staff and other staff on the tour route. Other areas of focus during the facility tour included, but were not limited to, levels of staff supervision, video monitoring and limits to cross-gender viewing. All signs and postings were in both in English and Spanish. Inmates can shower, dress, and use the toilet facilities without exposing themselves to employees of the opposite gender. Informal and formal conversations with employees and inmates regarding the PREA standards were conducted. Postings regarding PREA violation reporting and the agency's zero-tolerance policy for sexual abuse and sexual harassment were prominently displayed in all housing units, meeting areas and throughout the facility. Audit notice postings with the PREA auditor's contact information were posted in the same areas. The auditor notice postings were posted in April 2018. There was one letter mailed to the auditor because of the audit postings in the housing units. The inmate suffers from mental illness and was accusing seven other inmates of sexual wrongdoing, with no specified allegations. When the letter was brought to the attention of Complex officials, an investigation was immediately initiated, while the auditor was on-site, and the allegation was determined to be unfounded.

Staff-Inmate Interviews-Second Day

A total of 50 inmates were randomly selected to be interviewed. The interviews included one inmate who was hearing impaired, five inmates who were limited English proficient (LEP), one inmate in the Special Housing Unit (SHU) who was at a High Risk of Sexual Victimization, four inmates who reported sexual victimization during risk screening and one inmate identified with a limited cognitive disability. Additionally, three transgender inmates were interviewed. There was no self-identified intersex, bisexual or gay inmates interviewed. No inmates refused to be interviewed.

A total of 41 staff were interviewed which included 27 correctional officers (from all three shifts), six administrative staff members, one contract medical staff member and seven specialized staff members. The administrative staff interviewed included the Warden, Human Resource Manager (HRM), Captain, Chief of Psychology Services, Health Service Administrator and the Associate Warden/IPCM. During the tour, nineteen staff members were asked the questions outlined in the First Responder interview and all responses were appropriate.

Investigations

During the current auditing period, there were a total of 33 reported allegations of sexual abuse/sexual harassment. Of the 33 cases, 29 were found to be unsubstantiated and four were determined to be unfounded. Seventeen cases were inmate-on-inmate allegations and 12 were inmate-on-staff. At the time of the audit, there were no open cases.

Facility Characteristics

The Federal Correctional Complex, Beaumont, Texas, is located approximately 85 miles east of Houston, Texas, and 280 miles west of New Orleans, Louisiana. FCC Beaumont is an integral part of the Federal Bureau of Prisons System of classified penal and correctional institutions designed for the confinement of individuals who have violated the laws of the United States. The Complex consists of a Minimum-Security Prison Camp (SPC), a Low Security Correctional Institution (FCIL), a Medium Security Correctional Institution (FCIM), a High Security United States Penitentiary (USP) and an Administrative Services Operation (CAB), which provides various services to support the Complex.

The United States Penitentiary was activated on April 29, 1997. The USP is located on approximately 38 acres of land. It is an all male high security facility that currently houses 1498 inmates. The USP's inner compound is enclosed by the layout of its buildings, as well as a brick wall. It is also surrounded by a double security fence and a perimeter patrol road. The USP has seven perimeter towers and one internal tower which maintain constant visual supervision over the facility and the surrounding site. The USP has three, four-story housing units. Each building is organized into four units, making a total of 12 general population units. Each general population unit has two wings separated by a centrally located unit management area. There are 768 cells in general population housing. The Special Housing Unit includes the Administrative Detention and Disciplinary Segregation areas and houses 142 inmates.

The Satellite Prison Camp was activated in September 1997 and is located on approximately 42 acres of land. The SPC is an all male minimum security facility that presently houses 572 inmates. The SPC has two buildings which contain dormitory-style housing. Each building is organized into two units, making a total of four general population units. Each general population unit has two wings separated by a centrally located unit management area. One of the housing units, Unit GD, is designated as the 500-hour Residential Drug Abuse Program (RDAP) Unit.

FCI Beaumont Medium was activated in January 1999. It is an all male medium security facility and presently houses 1459 inmates. The institution is enclosed by a double security fence and a perimeter patrol road. The institution has three, four-story buildings located along the eastern border of the compound. Each building is organized into four units, making a total of 12 general population units. There are 768 cells for general population housing. One of the housing units, Unit MB, is designated as the 500-hour Residential Drug Abuse Program (RDAP) Unit. The Special Housing Unit includes the Administrative Detention and Disciplinary Segregation areas and houses approximately 143 inmates.

FCI Beaumont Low was activated in January 1996. It is an all male low security facility and currently houses 1678 inmates. The institution is enclosed by a double security fence and a

perimeter patrol road. The Low has a total of 86,072 square feet of programming area. There are three, two-story buildings located along the eastern border of the compound. Each building is organized into two units, making a total of six general population housing units. There are 768 cubicles in general population housing. Each unit has two wings, separated by a centrally located unit management area. One of the housing units, Unit WA, is designated as the 500-hour Residential Drug Abuse Program (RDAP) Unit. The Special Housing Unit includes the Administrative Detention and Disciplinary Segregation areas and is located along the northwestern border of the compound. The SHU houses approximately 142 inmates.

Summary of Audit Findings

Upon completion of the on-site visit, an exit briefing was held to discuss the audit findings. This briefing was held with the Complex Warden; Warden, Medium Security Institution; Warden, Low Security Institution; one Associate Warden/PREA Compliance Manager; four other Associate Wardens; Camp Administrator; and a representative from the BOP Program Review Division.

The auditor pre-audit and on-site audit activities support a conclusion that the Federal Correctional Complex is in compliance with the PREA standards. Employees at the facility were found to be extremely courteous, cooperative and professional. All areas of the facility were found to be clean and well maintained. There are adequate limits to cross-gender viewing and pat searches. The facility has adaptive measures in place to ensure disabled and LEP inmates can participate in and benefit from all aspects of the PREA process.

Hiring and promotion practices are consistent with sexual abuse safety measures. The facility has appropriate medical and victim advocacy networks in place and available, as needed. Staff and inmate PREA education and training are documented. Inmates acknowledged the admissions screening process included questions regarding any history of sexual abuse or victimization and whether they would like to identify a sexual preference. Intake, classification assessments and medical/mental health processes are efficient and seamless in addressing referrals based on victimization or abusiveness screening data. Related documentation is organized and stored in information systems available on a need-to-know basis. Reporting mechanisms are displayed in a conspicuous manner and inmates and staff members are aware of all reporting methods available to them. Systems are also in place for the coordination of responses to incidents of sexual abuse, as needed.

The facility also has sufficiently trained personnel who conduct administrative investigations. The Special Investigative Services (SIS) Department conducts administrative investigations at the Complex. The Federal Bureau of Investigation (FBI) and the Office of the Inspector

General (OIG) conduct criminal investigations. Staff indicated adequate training in all aspects of the PREA, particularly First Responder duties or actions to be taken in the event of a reported sexual abuse related incident. At the conclusion to the visit, the auditor thanked the Complex Warden and the FCC Beaumont staff for their hard work and dedication to the PREA process.

During the complex tour, the following concerns were noted and reported to the Complex Warden at the close of the first day:

Concern #1-No PREA signage was observed in the USP Visitation Area, Barber Shop or Workout/Cardio area located in the Recreation Department.

Corrective Action: Adequate PREA signage was added to the above-mentioned areas.

Concern #2-A blind spot was discovered near the dryers in the USP Laundry.

Corrective Action: A convex mirror was installed, eliminating the blind spot.

Concern #3-Shower curtains were missing in USP housing units CA, CB, DB and AB.

Corrective Action: New shower curtains were installed in units CA, CB, DB, and AB.

Concern #4-Blind spots were discovered near the Food Service dishwasher area, in the laundry and in the UNICOR Warehouse at the Medium Security Institution.

Corrective Action: A total of six convex mirrors were installed, eliminating the blind spots.

Concern #5-Blind spots were discovered in all 12 living units, near the ice machines, at the Low Security Institution.

Corrective Action: 12 convex mirrors were installed, eliminating the blind spots.

All areas of concern were corrected and inspected prior to the close-out meeting.

PS 5324.12, Sexually Abusive Behavior Prevention and Intervention Program, and IS Beaumont (BMX) 5324.12 address the requirements of this standard. The agency's zero-tolerance toward sexual abuse is clearly established and the policy also outlines the agency's approach to preventing, detecting and responding to sexual abuse and sexual harassment allegations. The Associate Warden serves as the Institution PREA Compliance Manager (IPCM) for the Complex. In addition to the IPCM, there is a designated National PREA Coordinator and a PREA Coordinator assigned to each regional office to ensure adherence to the PREA. The IPCM reports to the Warden. Zero-tolerance posters are displayed throughout every area of the complex. The agency and facility directives outline a zero-tolerance policy for all forms of sexual abuse and sexual harassment. Inmates are informed orally about the zero-tolerance policy and the PREA program during in-processing and are required to view a video during admission and orientation presentations. Additional program information is contained in the Admission and Orientation (A&O) Handbook, the Sexually Abusive Behavior Prevention and Intervention Pamphlet (SABPIP) and is posted throughout the facility, as observed during the tour. All PREA information, both video and written, is available in English and Spanish. Interpretive services are available for inmates who do not speak or read English or Spanish. Both institution staff and inmates are provided with a wealth of opportunities to become informed of PREA policies and procedures. All employees receive initial training and annual training, as well as updates throughout the year.

Interviews with the Warden and executive staff revealed compliance with the PREA and other safety and security issues are always a primary focus when reviewing staffing plans. In addition to the quarterly

workforce utilization meeting, the Warden meets weekly with his executive staff, including the Business Manager, Captain, Special Investigative Administrator (SIA) and the Human Resource Manager (HRM) to address staffing issues as they relate to the PREA. Quarterly workforce utilization minutes are on file. The facility has been provided with all necessary resources to support the programs and procedures to ensure compliance with the PREA standards. The audit included an examination of all video monitoring systems, inmate access to telephones and the Trust Fund Limited Inmate Computer System (TRULINCS) e-mail system, staff interviews and rosters.

Supervisory/Administrative staff members routinely make unannounced rounds covering all shifts and these rounds are documented. Interviews with staff confirmed unannounced rounds to all areas of the facility are conducted on a weekly basis, with no warning to employees. The facility does utilize convex mirrors to supplement security in areas where there are numerous corners or potential blind spots. During the tour there were areas identified by the auditor as having blind spots and convex mirrors were immediately installed to enhance the overall security in these areas.

Staff interviews revealed receipt of cross-gender pat search training during initial and annual training. The auditor observed that each unit is equipped with individual shower stalls for privacy while showering. The facility has implemented a policy that all staff working the unit will announce themselves prior to walking the range, thereby allowing inmates adequate opportunity to prepare from a privacy perspective. The inmates interviewed acknowledged they are allowed to shower, dress and use the toilet privately, without being viewed by staff of the opposite gender. Staff and inmates indicated that employees of the opposite gender announce their presence before entering a housing unit. The possibility of opposite gender staff entering the housing units is also announced over the speaker system at the beginning of each shift. Additionally, the auditor observed written notifications that opposite gender staff routinely come into the units posted within the common area of the housing units. The postings were in both English and Spanish. Staff members were aware of the policy prohibiting the search of a transgender or intersex inmate for the sole purpose of determining the inmate's genital status. During the past 12 months, there were no exigent circumstances that required cross-gender viewing of an inmate by a staff member at the FCC. During the tour of the complex, there were showers identified that needed shower curtains installed in the living units. All shower curtains were installed, and the areas were inspected prior to the auditor leaving the facility.

Correctional and medical staff members were interviewed concerning this standard and all were knowledgeable of the procedures required to secure and obtain usable physical evidence when sexual abuse is

alleged. Staff members were also aware the SIS department conducts investigations regarding sexual abuse allegations. All forensic medical examinations are conducted by SANE/SAFE staff at CHRISTUS Southeast Texas St. Elizabeth Hospital (CHRISTUS) in Beaumont, TX. The facility has a comprehensive medical service contract with the hospital and SANE/SAFE forensic medical examinations are a part of that agreement. An interview with the SANE/SAFE representative at CHRISTUS was conducted and the contract provider demonstrated a thorough knowledge of the PREA standards. The representative indicated that a SANE is available 24 hours a day, seven days a week. There were no SANE/SAFE examinations conducted during the past 12 months. Attempts were made by this auditor to contact two national victim advocacy agencies regarding FCC Beaumont. The Justice Detention International (DJI) did not respond to the auditor's attempts; however, a representative from the Rape, Abuse and Incest National Network (RAINN) responded with the name of a local victim advocacy group, located in the Beaumont area. Documentation on file confirmed that, over the last 9 months, the FCC has made multiple, unsuccessful attempts to establish an MOU with the local victim advocacy group recommended by RAINN, along with other like agencies in the area.

PS 5324.12 and the FBI Memorandum of Understanding address the mandates of this standard. Administrative and criminal investigations are completed on all allegations of sexual abuse/sexual harassment. The SIS, the Office of Internal Affairs (OIA), the FBI and the Office of the Attorney General conduct all investigations. The SIA was interviewed and proved very knowledgeable concerning the protocols for conducting investigations of alleged sexual abuse/sexual harassment. There are 253 agency investigators and five trained investigators at the FCC. The FBI conducts the criminal investigations for the institution. The BOP/FBI MOU, dated August 1996, delineates each agency's responsibilities relative to an incident involving a criminal act related to sexual abuse.

There were 33 allegations of sexual abuse and sexual harassment during the auditing period and, in all cases, investigations were initiated and completed in accordance with the PREA standards and agency policies. The documentation for all investigations was reviewed by the auditor. The facility utilizes a PREA Compliance Manager Information Tracking Log to ensure all required steps of the investigation are completed and are timely. The tracking form is maintained by the SIS. The information tracked includes the date of the allegation, name of the victim/perpetrator, SHU placement/reviews, initial two-day after-action review, full protocol, investigation outcome/date, date inmate notified of outcome and retaliation monitoring. A

review of documentation confirmed that all investigators received training in conducting sexual assault investigations in confined spaces/prisons. Interviews with staff, to include an investigator, and an examination of supporting documentation confirm the Complex's compliance with this standard.

Additionally, contractors and volunteers are provided training relative to their duties and responsibilities. All staff members are mandated to receive training annually and the curriculum includes an extensive review of PREA requirements. Training curriculum, training sign-in sheets and other related training documentation was reviewed by the auditor. Interviewed staff verified the requirement to acknowledge, in writing, not only that they received PREA training, but that they understood it. If an employee is reassigned from a facility that housed inmates of the opposite sex/gender, that employee is scheduled to receive additional training.

A staff member conducts an education program regarding the PREA for all inmates within 30 days of their arrival at the facility. The program includes definitions of sexually abusive behavior and sexual harassment, prevention strategies and reporting modalities. Inmates also view a comprehensive orientation video that explains the facility's zero-tolerance policy and covers the inmate's right to be free from sexual abuse, sexual harassment and retaliation. The inmates have access to the TRULINCS computer program system which also provides them with PREA information.

There are PREA posters displayed throughout the facility and in each housing unit, and a "Hotline" telephone number, which may be called to report sexual abuse or sexual harassment. Since the "Hotline" telephone number is an 800-toll-free number, inmates are advised via the SABPIP Pamphlet to contact a member of their unit team to place the call. The OIG mailing address is listed in the A&O Handbook and posted in each housing unit for inmate correspondence concerning any sexual abuse or sexual harassment allegation. There is also a translation language line available to LEP inmates. The auditor was provided a random sampling of A&O Checklists/Signature Sheets to verify that inmates, admitted during the auditing period, received the SABPIP education and relevant written materials. All inmates are required to acknowledge completion of PREA education. During the interview process, randomly selected inmates indicated they received information about the facility's rules against sexual abuse/sexual harassment, when they arrived at the facility. They further indicated they were advised about their right not to be sexually abused/sexually harassed, how to report sexual abuse/sexual harassment and their right not to be punished for reporting sexual abuse/sexual harassment. Inmates were aware of available services outside of the facility for dealing with sexual abuse.

Risk management staff review all relevant pre-sentence documentation and information from other confinement facilities and reassess an inmate's risk level, as necessary, within 30 days of his arrival. Agency policy prohibits inmates from being disciplined for refusing to answer, or for not disclosing complete information in response to questions regarding their mental/physical health, developmental disability, sexual preferences, sexual victimization history and perception of vulnerability. Housing and program assignments are made on a case-by-case basis and inmates are not placed in housing units based solely on their sexual identification or status. Mental health and unit staff meet with each inmate in SHU status at least once each week. A Safeguarding of Inmates Alleging Sexual Abuse/Assault Allegation Form is completed when considering all appropriate alternatives for safeguarding alleged inmate victims. the SHU operations and an examination of policy/documentation confirm the FCC's compliance with this standard.

The facility has procedures in place for staff to document all allegations. There are posters and other documents on display throughout the facility which also explain reporting methods. During the tour of the facility, several TRULINCS computers were observed in each housing unit. Inmates were able to demonstrate to the auditor how to log into the TRULINCS system and how to file a PREA report, if needed. Staff members promptly accept and document all verbal, written, anonymous, private, and third-party reports of alleged abuse. Family and friends of inmates may report sexual abuse/sexual harassment by using the BOP website, phoning the OIG or contacting facility staff. All interviewed inmates confirmed awareness of the multiple methods of reporting sexual abuse/assault allegations. Inmates at the FCC are not detained solely for civil immigration purposes. Interviews with staff and inmates, observations of posters addressing reporting methods and an examination of policy/documentation confirm the FCC's compliance with this standard.

Allegations of physical abuse by staff shall be referred to the OIA, in accordance with procedures established for such referrals. Policy addresses the filing of emergency administrative remedy requests. If an inmate files the emergency grievance with the institution and believes he is under a substantial risk of imminent sexual abuse, an expedited response is required to be provided within 48 hours. Best efforts are made to provide Regional Office and Central Office expedited appeal responses within five calendar days.

If an inmate reasonably believes the issue is sensitive and the inmate's safety or well-being would be placed in danger, if the remedy became known at the institution, the inmate may submit the remedy directly to the appropriate Regional Office. There is no prohibition that limits third parties, including fellow inmates, staff members, family members, attorneys and outside victim advocates in assisting inmates in filing requests for grievances relating to allegations of sexual abuse or filing such requests on behalf of inmates. There were no grievances filed involving PREA related issues during the past 12 months. There were no grievances alleging

All staff carry a laminated first responder card with them at all times. This card lists all the steps necessary for a first responder in the event of a PREA incident. All requirements of 115.64a would be met by following these steps. The Operations Lieutenant would continue to protect the inmate and notify medical, mental health, the ERT and administrative/executive staff. In the past 12 months, there were no allegations that an inmate was sexually abused and a first responder was required to separate the victim and the abuser.

In the past 12 months, 100% of inmates who disclosed prior victimization during screening were offered a follow up meeting with a medical or mental health practitioner. Additionally, 100% of the inmates who have previously perpetrated sexual abuse, as indicated during the screening, were offered a follow up meeting with a mental health practitioner. Treatment services are offered without financial cost to the inmate, as confirmed by observation and a review of intake screening documents. Screening for prior sexual victimization in any setting is conducted by unit team staff during in-processing procedures. In-processing procedures also include screening for previous sexually assaultive behavior in an institutional setting or in the community. When indicated, staff members ensure that the inmate is offered a follow up meeting with a mental health practitioner within 14 days of the intake screening. Information related to sexual victimization or abusiveness is limited to medical and mental health practitioners and other staff with a need-to-know for the purpose of determining treatment plans, security, housing, work, program assignments and other management decisions. Signed and dated informed consents are obtained from inmates before reporting prior sexual victimization which did not occur in an institutional setting. Agency policy prohibits inmate co-pays for medical treatment from being applied to victims of sexual abuse and all treatment is offered at no financial cost to the inmate. prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate. This was the second PREA audit of this facility. The previous PREA audit was in May 2015. The auditor was allowed access to all areas of the facility and had access to all required supporting documentation. The auditor was able to conduct private interviews with both inmates and staff. All BOP facilities have received at least one PREA audit since August 20, 2012. At least one-third of all BOP facilities were audited during the one-year period after August 20, 2012. The auditor was provided supporting documentation before and during the audit. Notifications of the audit posted throughout the FCC allowed inmates to send confidential letters to the auditor prior to the audit. There was one confidential letter mailed to the auditor as a result of the audit postings in the housing units. The inmate suffers from mental illness and was accusing seven other inmates of sexual wrongdoing, with no specified allegations. When the letter was brought to the attention of Complex officials, an investigation was immediately initiated, while the auditor was on-site, and the allegation was determined to be unfounded.

PREA training for staff and inmates is documented and all stakeholders receive the appropriate level of training and are knowledgeable of the intent of the PREA and the tools available to ensure prevention, detection, reporting and response to sexual abuse incidents. Sexual abuse and victimization propensity screening is well established and tracked in an organized fashion.
