Message for Inmate Population

November 9, 2021

Visitation privileges are tentatively scheduled to resume under the COVID-19 Operational Level 1, Color Green, guidelines. The following guidelines and procedures will be implemented to ensure CDC social distancing protocols are followed.

The following guidelines will be followed to protect the health and safety of staff, inmates, and visitors:

- **Mandatory Face Coverings:** Inmates and visitors must wear face coverings at all times and perform hand hygiene immediately before and after the visit.
- **Visitor Parking:** Visitors will be required to park in designated parking spaces as directed by staff. The visitors will remain in their vehicles until called for on their cellphone, then proceed to the Front Lobby for screening by staff.
- **Processing into Visitation:** Visitors will be required to fill out all forms prior to arrival at the institution. Visitation forms (Title 18 Form) can be found at www.bop.gov Visiting Regulations.
- **Visitors per Inmate:** The number of visitors allowed in the visiting room will be appropriately reduced, promoting social distancing. A maximum of four (4) visitors will be allowed per inmate. (Children are included in the total count)
- **Visitor Bathrooms:** Visitors will be permitted to use the restrooms one at a time. Adult visitors will be permitted to assist small children.
- **Close Contact Preventions:** Food and beverages will not be allowed during visitation. *Special provisions will be made to allow for baby formulate/milk.*
- **Visiting Schedule:** In-Processing visitors begins at 8:00 a.m. and ends at 2:00 p.m. Visitation is a first come first serve basis. The order in which an inmate receives a visit will begin as visitors are processed in the Front Lobby. Visitation will end at 3:00 p.m.
