COVID-19 Visitation Guidelines

Visitation for SCP Mendota and FCI Mendota will be conducted in compliance with the COVID-19 Matrix level for the institution on the Friday prior to the first day of visitation. Specific information for each level is as follows:

### **CAMP VISITATION**

Visitation will be non-contact/contact based upon the current COVID-19 Matrix level seen above. Appropriate social distancing will be enforced and marked by the use of tape to assist in mitigating the spread of Covid-19. Due to space limitations there will be no more than thirteen (13) inmates and no more than four (4) visitors per inmate.

### **FCI VISITATION**

Visitation will be non-contact/contact based upon the current COVID-19 Matrix level seen above. Appropriate social distancing will be enforced and marked by the use of tape to assist in mitigating the spread of Covid-19. Due to limitations on available space, there will be no more than nineteen (19) inmates and no more than four (4) visitors per inmate.

- Inmates who are on Quarantine or holdover status will not be allowed visitation. All visitors will be screened for symptoms and their temperature will be checked upon entry into the facility. Visitors who are sick or symptomatic will not be allowed to visit.
- Both inmates and visitors must wear face coverings at all times and perform hand hygiene prior to and after the visit. Visitors are expected to wear and will be screened for appropriate face coverings. No face coverings such as bandanas or those with any advertising will be allowed.
- If Level 2 Operations are in effect, there will be no physical contact of any kind, this includes embracing at the beginning and end of a visit. Additionally, inmates and their visitors will not be authorized to take photographs based on the inability to maintain appropriate social distancing.
- Any failure to follow the additional procedures to our visitation rules and regulations will result in the end of the visit. Any inmate who fails to maintain a non-contact visit during Level 2 Operations may be placed in quarantine status until medically cleared.

### **LEGAL VISITS**

- Requests for legal visits will be conducted on a case-by-case basis, taking into consideration the local community transmission rate, the institution transmission rate, as well as the institution vaccination rate. Ordinarily, legal visits will be conducted provided an active outbreak within the facility of local community is not currently underway.
