Audit Findings

Audit Narrative

Pre-Audit Preparation

Prior to the on-site visit, a representative from the External Auditing Branch, Program Review Division of the Bureau of Prisons (BOP), conducted an on-site "pre-audit" of the facility to ensure PREA compliance. BOP Central Office staff are extremely knowledgeable of the PREA and serve as agency liaisons for all PREA audits. At the direction of the BOP Management Analyst, all policies and supportive documentation were provided to the auditor for review, prior to the on-site visit. Policies and documentation were provided such as Program Statements (PS), Institution Supplements (IS) and other forms/memos. Program Statements are agency-wide governing policies developed by the BOP and Institution Supplements stipulate institution specific policies, in the event there is no agency-wide policy or site-specific policy required to expand on agency Program Statements. The results of the internal audit were discussed with the auditor prior to the on-site visit.

Sampling Methodology- Inmates

FCI Ray Brook's inmate sample size was based on the population census on the first day of the audit, along with the established census criteria outlined by the PREA Resource Center (PRC). The inmate population was 731 on day one of the audit process. A total of thirty (30) inmates (male) were identified to participate in the inmate sample (random 20 and targeted 10). The targeted sample included zero disabled inmates, ten (10) Limited English Proficient (LEP) inmates, zero self-identified gay inmates and zero inmates who reported sexual victimization during risk screening. No inmates were in the Special Housing Unit (SHU) for High Risk of Sexual Victimization, no inmates were identified with limited cognitive disability and no inmates self-identified as being gay, bisexual, transgender or intersex. Additionally, no inmates refused to be interviewed.

Sampling Methodology - Staff/Volunteers/ Contractors

During the tour, two random staff members were informally sampled and asked the questions outlined in the First Responder interview questionnaire; both staff members answered correctly. Informal interviews were not included in the random staff count, because the information was obtained during informal conversations.

Personnel were randomly selected from a roster of individuals scheduled to work during the onsite audit process. Ten (10) employees were selected and interviewed from different disciplines throughout the facility, to include medical, case management and intake staff. Correctional Officers and Lieutenants from each shift were included in the interviews.

Twenty-eight (28) specialized staff members, such as the Associate Warden of Programs/PREA Compliance Manager, the Chief of Psychology Services, three additional intermediate or higher-level facility staff, two Special Investigative Services Lieutenants, the Health Services Administrator, and two Intake Officers were also interviewed during the on-site audit. Additionally, the auditor telephonically interviewed three (3) volunteers, three (3) contractors and a local Sexual Abuse Nurse Examiner (SANE).

First day- Briefing and Tour (On-site Audit)

The on-site visit for the PREA (Prison Rape Elimination Act) compliance audit of the Federal Correctional Institution (FCI) located in Ray Brook, New York, was conducted May 15-17, 2018 by The Nakamoto Group, Inc. certified auditor Sonya Love. This is the second PREA audit for this facility. Upon arrival at the facility, an in-briefing meeting was held with the Warden, Associate Warden of Programs/PREA Compliance Manager, Health Services Administrator, Captain, various department heads, an American Correctional Association (ACA) Auditor and one Management Analyst from the BOP Program Review Division. The standards used for this audit became effective August 20, 2012. This auditor discussed the information contained in the Pre-Audit Questionnaire with the Institutional PREA Compliance Manager (IPCM). The National PREA Coordinator and the Director for the BOP were previously interviewed telephonically. As part of the audit, a review of all agency and local facility PREA policies was conducted, as well as a tour of the facility.

The tour of FCI Ray Brook included the intake processing areas, all housing units, the Special Housing Unit (SHU), the Health Services Department, Recreation, Food Service, facility supporting areas, Education, Visiting Room and programming areas. During the tour, it was noted that there was sufficient staffing and surveillance cameras to ensure a safe environment for inmates and staff. Signs were posted (in English and Spanish) that indicated employees of the opposite gender were present in the housing units. Informal and formal conversations with employees and inmates regarding the PREA standards were conducted. Postings, regarding PREA violation reporting and the agency's zero tolerance policy toward sexual abuse and sexual harassment, were prominently displayed in all housing units, meeting areas and throughout the facility. Audit notice postings with the PREA auditor's contact information were in the same areas. These notices were posted six weeks prior to the May 15-17, 2018 on-site audit. The auditor did not receive correspondence from any inmates.

Staff-Inmate Interviews-Second Day

On the second day, randomly selected personnel were interviewed. All personnel interviewed confirmed they were aware of the institution's zero tolerance policy and were aware and understood their responsibility and duty to protect inmates from sexual abuse/sexual harassment. Each staff member interviewed affirmed an awareness and understanding of the

role and duties of a first responder, in the event of a PREA related allegation. In addition, staff could clearly explain their role as part of a coordinated response. All interviewed staff, contractors (3) and volunteers (3) demonstrated an understanding of the PREA and their responsibilities under the PREA mandate.

Investigations

During the current auditing period, there were a total of zero reported allegations of sexual abuse/sexual harassment and no investigations were initiated.

Facility Characteristics

FCI Ray Brook is in the Adirondack Mountains in Upstate New York. FCI Ray Brook is situated midway between the villages of Lake Placid and Saranac Lake (Route 86) and is 70 miles from the Canadian Border and 150 miles north of Albany, the State Capitol. Lake Placid has been the only site to host two Winter Olympics (1932 and 1980). The facility is better known as the site of the 1980 Olympic Village. During the 1980 Olympics, Ray Brook housed over 2,000 athletes who participated in the 1980 Winter Olympic Games in Lake Placid, New York. After the Olympics, the facility and land were re-missioned as a federal correctional facility called FCI Ray Brook.

FCI Ray Brook has a rated capacity of 749 for housing adult male inmates. The FCI is a medium security facility. Currently, the facility has four housing units, consisting of a blend of two, four and six-man rooms. The FCI also has two housing unit annexes and one Special Housing Unit (SHU). One unit, Genesee A-Unit, is handicap accessible. Currently, one housing unit, Ausable, is closed. FCI Ray Brook has an electronic surveillance system that includes cameras strategically placed on the grounds to ensure the safety and security of both inmates and staff.

The mission of the Education Department at FCI Ray Brook is to provide mandatory literacy and English as a Second Language (ESL) programs as required by law, as well as other Education related programs that meet the needs and interests of the inmate population. As previously mentioned, literacy programming, including GED and ESL, are the core programs of the Department. To meet the literacy requirement, inmates who cannot verify their high school diploma or previous GED certification, are placement tested and enrolled in the literacy program.

Adult Continuing Education classes consist of courses in resume writing, interview skills, basic Spanish, accounting and cultural awareness. Job readiness skills, which prepare participants for the mock job fairs, include scenarios dealing with difficult situations,

responding to questions related to incarceration, where to locate jobs, attitude and character, and developing good interviewing skills.

The Education Department also provides options for the positive use of an inmate's leisure time and to enhance their successful reintegration into the community. Some of these programs include Vocational Trades, Credentialed Alcohol Substance Abuse Counseling, Parenting, Reentry, a variety of general interest classes and college classes through the Pell Pilot program.

The Religious Services Department is staffed by one Supervisory Chaplain and one Religious Services Assistant. Chaplaincy Services provides accommodation of basic religious services, to include authorized congregate services and individual spiritual enrichment time. The Chaplain oversees religious programming for all inmates and pastoral care for both staff and inmates. FCI Ray Brook's religious disciplines include 11 faith groups that have scheduled time for inmate participation, such as Catholic, Protestant, Muslim, Rastafarian, Nation of Islam, Native American, Moorish Science Temple of America, Hindu, Santeria and Judaism.

FCI Ray Brook has two psychologists who are available to provide counseling and other mental health services. The Psychology Services Department provides a comprehensive delivery of psychological services, to include screenings, assessment and treatment of mental health or drug abuse problems, individual and/or group counseling, psycho-educational classes, self-help and supportive services and referrals to Health Services for medical treatment of a mental illness. Based on individualized assessments, institution psychologists provide recommendations to management staff to assist in making decisions of where to house inmates at high risk of abusiveness separately from those determined to be at higher risk of victimization. FCI Ray Brook's Psychology Services Department also provides clinical care for those inmates in the population who make an initial report of sexual victimization within a correctional institution.

FCI Ray Brook requires all staff, within all disciplines, such as Education/Recreation, Psychology Services, Unit Management and Religious Services, to report any knowledge, suspicion, or information regarding an incident of sexual abuse or sexual harassment that occurs in the facility.

Summary of Audit Findings

FCI Ray Brook has imposed adequate limits to cross-gender viewing and searches. The facility has adaptive measures in place to ensure disabled and Limited English Proficient inmates can participate in and benefit from all aspects of the PREA process. Hiring and

promotion practices are consistent with sexual abuse safety measures. The facility also has appropriate medical and victim advocacy networks in place and available, as needed. PREA education and training is documented. Inmates acknowledged the admissions screening process included questions regarding any history of sexual abuse or victimization and whether they would like to self-identify a sexual preference. Intake classification assessment and medical/mental health processes are well-organized and continuous in addressing inmate referrals based on self-disclosure or documented prior histories of victimization or abusiveness screening data. Confidential data or documents related to victimization, abusive histories or treatment modalities were well organized and maintained in a storage system restricted on a need-to-know basis.

Reporting mechanisms were displayed in a conspicuous manner and inmates and staff members were aware of all reporting methods available to them. Systems were in place for a coordinated response to incidents of sexual abuse, as needed. FCI Ray Brook also had sufficiently trained personnel to conduct administrative investigations. The Special Investigative Services (SIS) Unit was responsible for conducting administrative investigations at FCI Ray Brook. The Federal Bureau of Investigation (FBI) and the Office of the Inspector General (OIG) conduct criminal investigations. Staff at the facility affirmed that they received adequate training in all matters related to the PREA, particularly First Responder duties or actions to be taken in the event of a reported sexual abuse related incident. At the culmination of the audit, the auditor thanked the Warden and her staff for their hard work and dedication to the PREA process.

Upon completion of the on-site audit, an exit briefing was held to discuss the audit findings. This briefing was held with the Warden and the Management Analyst from the BOP Program Review Division. The auditor was provided with extensive and lengthy files, prior to the audit, which supported a conclusion of compliance with the PREA standards. Employees at FCI Ray Brook were very courteous, cooperative and professional. All areas of the facility were found to be clean and well-managed.

Summary of Corrective Action (if any)

1. Some inmates were not able to shower, dress, and use the toilet facilities without exposing themselves to employees of the opposite gender. The cells required the placement of an opaque film to allow inmates to dress and use the toilet in their cells. This deficiency was corrected during the onsite audit.
2. Standard 115.13 - A blind spot was identified during the tour of the kitchen. Appropriate staff quickly installed a convex mirror in the corner identified by the auditor, as having a blind spot, to correct the problem.
3. A section of the inmate A & O Handbook was in conflict with BOP Program Statement 1330.18, Administrative Remedy Program. At best the handbook was unclear and compelled inmates to use the informal grievance process to resolve a PREA related administrative remedy (grievance). FCI Ray Brook, in practice, re-routes PREA related grievances to Special Investigative Services for investigation. Because the facility identifies the inmate handbook as a resource and mechanism to educate inmates about sexual abusive behaviors and how to report incidents of sexual abuse and sexual harassment, the handbook should be accurate and eliminate conflicting language. Prior to the conclusion of the on-site audit, FCI Ray Brook staff revised the inmate handbook to reflect the exact language outlined in PS 1330.18, which complies with Standard 115.52. No further corrective action is required.
4. PS 1330.18 addresses the filing of emergency administrative remedy requests. If an inmate files the emergency grievance with the institution and believes he/she is under a substantial risk of imminent sexual abuse, an expedited response is required by the BOP within 48 hours. The BOP's program statement supporting Standard 115.52; however, the A&O Handbook, contradicted PS 1330.18 by indicating the response must be made as soon as possible, usually within seventy-two (72) hours from receipt of the complaint. Prior to the conclusion of the on-site audit, FCI Ray Brook staff revised the inmate handbook to reflect the exact language outlined in PS 1330.18, which complies with Standard 115.52. No further corrective action is required.

Program Statement (PS) 5324.12 Sexually Abusive Behavior Prevention and Intervention Program and Institution Supplement (IS) 5324.12(b) Sexually Abusive Behavior Prevention and Intervention Program address the requirements identified in this standard. The agency has appointed a psychologist assigned to the BOP Reentry Services Division as their National PREA Coordinator. The Warden has appointed the Associate Warden of Programs as the Institutional PREA Compliance Manager (IPCM). The IPCM reports directly to the Warden regarding all PREA related concerns. Previous interviews with the National PREA Coordinator and an on-site interview with the IPCM confirmed that each has

sufficient time and authority to coordinate efforts to comply with PREA standards. The agency and facility directives outline a zero-tolerance policy for all forms of sexual abuse and sexual harassment. Inmates are informed orally about the zero-tolerance policy and the PREA program is also reviewed by inmates during in-processing procedures via video. In addition, the inmates are also educated through the admission and orientation procedures. PREA education is offered in English and in Spanish. Inmates are also informed about the program and zero-tolerance in the Admission and Orientation (A&O) Handbook, a pamphlet and through postings throughout the facility, as observed during the tour. All written documents are available in English and Spanish. Additional interpretive services are available for inmates who do not speak or read English. All interviews with staff, volunteers (3), contractors (3) and inmates confirmed that each were aware of the zero-tolerance policy towards all forms of sexual abuse/sexual harassment. The commitment to the enforcement and implementation of the PREA, along with an examination of policy and documentation supporting the facility's compliance with this standard.

The agency meets the requirements of Standard 115.12. A review of the documentation submitted confirmed the agency requires other entities contracted with for the confinement of inmates (privatized prisons and residential reentry centers or "halfway houses") to adopt and comply with the PREA standards. All agency contractual agreements were modified to incorporate the language requiring all contractors to adopt and comply with PREA standards. PS 3000.03, Human Resource Management Manual, the facility staffing report and the Workforce Utilization Committee meeting minutes address all the requirements of Standard 115.13. A review of the facility staffing plan and the quarterly Salary and Workforce Utilization Committee meeting minutes for the previous 12 months confirmed that PREA issues were considered when filling positions and developing work rosters/assignments. Interviews with the Human Resource Manager and the Associate Warden/Institution PREA Compliance Manager confirmed that the facility considers the items detailed in Standard 115.13 when developing a staffing plan. The facility reviews the staffing plan at least quarterly. The IPCM is a member of the Salary and Workforce Utilization Committee and may provide input as to whether adjustments to the staffing plan may be required to meet PREA requirements. There have been no judicial findings of inadequacy, findings of inadequacy from federal investigative agencies or findings of inadequacy from internal or external oversight bodies relevant to this standard. All essential posts are filled on each shift and no essential posts are kept open for salary savings. The review of Institution Duty Officer unannounced PREA rounds logs confirmed that intermediate-level or higher-level supervisors (department heads at a minimum) conduct and document such visits throughout the institution. Staff members are prohibited from alerting other employees regarding unannounced rounds. Interviews with inmates and housing unit officers also confirmed that random, unannounced rounds are conducted by Institution Duty Officers daily, including nights and weekends. An examination of supporting documentation also confirms the facility's compliance with this standard.

PS 5324.12, page 17, and PS 5521.06, Searches of Housing Units, Inmates and Inmate Work Areas, address the requirements of the standard. The facility's overall rated capacity exceeds 50 inmates. FCI Ray Brook does not permit cross-gender strip searches or cross-gender visual body cavity searches, except in exigent circumstances or when performed by medical practitioners. There were no cross-gender visual body cavity or strip searches conducted in the facility during the audit period. Random and specialized staff interviewed confirmed that they are required to document all cross-gender strip searches and cross-gender visual body cavity searches. Interviews with the same staff confirmed that they were aware of the prohibition of visual body cavity or strip searches of the inmates by staff of the opposite sex except in exigent circumstances. Staff interviews also confirmed that female officers have been trained to conduct cross-gender pat searches.

The auditor confirmed through observations, during the tour of all housing units, that inmates are permitted to shower, perform bodily functions and change clothing privately. The agency and facilities

have an “announce” policy and procedures requiring staff of the opposite sex to announce their presence or otherwise notify the inmates when entering an inmate housing unit. Random and targeted interviewed inmates confirmed that female staff members announce their presence in this manner when entering a housing unit. The practice was observed during the tour of the entire facility. Random staff interviewed confirmed that employees do not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate’s genital status. Interviews with inmates confirmed that they had been pat-searched by officers properly and professionally. Staff Training Acknowledgement Forms were examined by the auditor. Interviews with random and specialized staff, the auditor’s observations and an examination of documentation, such as the Staff Training Acknowledgement Form, confirm training in this area is in compliance with Standard 115.15.

There were 10 Limited English Proficient inmates interviewed by the auditor. There were no disabled inmates or inmates identified with limited cognitive disability.

All inmates (random and targeted) interviewed, to include the visually impaired inmates, verified that they were instructed about PREA compliance and felt safe from sexual abuse. All PREA related information, including postings, brochures and handouts are available in English and in Spanish, which was confirmed through inmate interviews and auditor observations, during the tour. An interview with a limited English proficient inmate also confirmed the availability and use of the staff and telephonic interpretive services. As needed, the facility would employ an American Sign Language (ASL) Service for inmates who need assistance using sign language to communicate. The facility also employs staff members who are proficient in languages other than English. Staff interviews (random and specialized) confirm that the facility does not use inmate interpreters, inmate readers or other types of inmate assistants in the performance of first responder duties or during the investigation of an inmate's allegations. Interviews with first responders, medical, mental health and investigative staff confirmed their awareness of the prohibition for using inmate interpreters for PREA compliance functions. All employees who have contact with inmates have had a background investigation in addition to fingerprinting and inquiry into the FBI's National Crime Information Center (NCIC). Re-check of employee backgrounds takes place every five years.

Contractors and volunteers who have regular contact with inmates also have criminal background checks completed prior to having contact with inmates. Volunteer and contractor background checks are repeated yearly. The facility does not hire or promote anyone who may have contact with inmates and does not enlist the services of any contractor who may have contact with inmates who has engaged in any type of sexual abuse/harassment. Employees have a duty to disclose such misconduct and material omissions regarding such misconduct would be grounds for termination. Submission of false information by any applicant is grounds for not hiring the applicant.

The Human Resource Manager was interviewed and confirmed that the agency attempts to contact prior employers for information on substantiated allegations of sexual abuse or resignations which occurred during a pending investigation of sexual abuse. The Human Resource Manager also confirmed that the agency, not the FCI Ray Brook Human Resource Department, provides information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom such employee has applied to work. Interviews with correctional and health services personnel confirmed that they were all knowledgeable of the required procedures for obtaining, preserving and securing physical evidence, when sexual abuse is alleged. Staff members were aware that the Special Investigative Services (SIS) Lieutenant, the Office of Internal Affairs (OIA), the Office of Inspector General (OIG) or the Federal Bureau of Investigation (FBI) conduct investigations relative to sexual abuse/sexual harassment allegations. The agency follows a uniform evidence protocol as described in the U.S. Department of Justice's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents." Victims of sexual assault are referred to health services for initial examination and treatment. Such treatment would be for life preservation only and the victim would be transported to a community hospital for examination, treatment and forensic evidence gathering by a SANE. All sexual abuse victim advocacy, examinations, treatment, testing and follow-up care are provided without cost to the victim. Facility staff members have been trained as victim advocates. Routinely, administrative investigations are conducted by trained investigators who are full time employees of the facility. The Warden generates the referral to the outside agency. A review of FCI Ray Brook's training records confirmed that investigators have received training offered by the BOP on the investigation of sexual abuse and sexual harassment in confinement settings. During this audit period, FCI Ray Brook had no incidents where a victim requested the services of a qualified community based organization or a staff member to accompany or provide victim support services as confirmed by the Warden. Interviews with staff and a SANE (telephonically) from a local hospital and the examination of relevant documentation also confirm the facility's compliance with Standard 115.21.

PS 5324.12 addresses the requirement of Standard 115.22. The policy requires administrative or criminal investigations to be completed on all allegations of sexual abuse/sexual harassment. Administrative investigations are routinely assigned to trained investigators working in the Special Investigative Services (SIS) Department. If, during an investigation, evidence surfaces indicating criminal misconduct, the case would be initially referred to the FBI for criminal investigation. The Special Investigative Agent (SIA) and Special Investigative Services Lieutenant were each interviewed, and both were aware of their responsibilities in the investigative process. The FBI would conduct criminal investigations for the facility, involving inmate-on-inmate sexual abuse and the Office of the Inspector General (OIG) would investigate staff-on-inmate criminal sexual abuse. An investigation would never be terminated due to an inmate being transferred or released or an employee leaving the agency. FCI Ray Brook has an Evidence Recovery Team (ERT), which is a group of specially trained staff who would be called to a potential crime scene to preserve evidence. A review of training documents confirmed that all investigators received instruction in conducting sexual assault investigations in confined spaces/prisons. Interviews with staff and the investigators and an examination of training documentation, such as the Investigative Intelligence Training Records and training curriculum, confirm the facility's compliance with Standard 115.22.

All BOP employees are considered correctional workers and all new employees attend training locally and at the Federal Law Enforcement Training Center. This training addresses all the topics identified in the PREA standard. Related education is provided annually during refresher training. The review of the facility lesson plans, training logs and PREA Power Point Presentations confirmed that the provided training also addressed all elements identified in the standard. Staff must acknowledge in writing their understanding of the PREA. Employees have PREA information noted on their desk computers and carry a PREA reference card. Staff annual training files were reviewed and contained documentation supporting compliance with this standard. All staff interviewed indicated that they received the required PREA training initially and annually. The Warden has periodically issued memos (emails) to staff reminding them of and clarifying various PREA issues. Electronic staff meetings are also held, addressing PREA and other safety and security issues (transgender inmate management is a specific topic covered). Officers receive additional PREA training/updates quarterly and officers assigned to the Special Housing Unit (SHU) also receive additional training. The extensive training provided and staff knowledge of the PREA requirements confirm the facility meets the compliance requirements of Standard 115.31.

Contractors (3) and volunteers (3) randomly interviewed (telephonically) confirmed that training was provided, and that they understood the agency's zero-tolerance policy for sexual abuse/sexual harassment and their responsibilities under the Prison Rape Elimination Act. A review of the PREA contractor and volunteer training curriculum confirmed that the level of instruction was appropriate for the services provided and the training included education on the facility's zero-tolerance of sexual abuse/sexual harassment and the mandatory reporting policies. During in-processing procedures, each inmate receives an Inmate Handbook and a pamphlet describing the agency's PREA compliance program. The information identifies the key elements of the program and informs inmates of the zero-tolerance policy regarding sexual abuse and sexual assault and multiple ways to report sexual abuse/sexual harassment. The information also informs the inmates that both male and female staff members routinely work in and monitor the housing units. The information is available in English and Spanish. A staff member conducts an education program regarding the PREA for all inmates within 30 days of their arrival at the facility. The program includes definitions of sexually abusive behavior and sexual harassment, prevention strategies and reporting modalities. Inmates also view a comprehensive orientation video that explains the facility's zero-tolerance policy and covers the inmate's right to be free from sexual abuse, sexual harassment and retaliation. Inmates also have access to TRULINCS, a computer program system which also provides PREA information and can be used as a reporting outlet. Staff interpreters and telephonic translation services are available to inmates who are not proficient in English. Staff members routinely conduct "town hall" meetings (group meetings that provide information and a question/answer session) in the housing units to address issues that may include PREA discussions. Inmates sampled during random interviews confirmed that they received PREA information and they were aware of numerous reporting methods to include anonymous and third-party reporting, the zero-tolerance policy and their right to be free from retaliation. The tour of the facility confirmed that PREA education posters were prominently displayed in all housing units, common/program areas and TRULINCS. Interviews with staff (random and specialized) and an examination of documentation also confirm that the facility meets the compliance requirements for Standard 115.33.

When required, both medical and mental health providers at FCI Ray Brook are available for immediate call back to the facility during off duty hours. A review of medical and mental health personnel training records by the auditor confirmed that these employees receive the same PREA training as correctional officers and understand their duty to report any knowledge of sexual abuse/sexual assault, even when disclosed during a health care encounter. Further, a review of training records confirmed that all mental health and medical staff have also received specialized training on victim identification, interviewing, reporting and required clinical interventions. Training does not refer to certifications needed to conduct forensic examinations. All cases requiring the processing of sexual assault evidence collection kits are transported to a community hospital where Sexual Abuse Nurse Examiners are available at all times (a SANE was interviewed and confirmed access to these services). Interviews with medical and mental health staff also confirmed the provision of specialized training and that they are aware of their duty to report and address allegations and suspicions of sexual abuse/sexual harassment. FCI Ray Brook met the requirements of Standard 115.35.

PS 5324.12 addresses the requirements of Standard 115.41. All inmates are immediately assessed for a history of sexual abusiveness and risk of sexual victimization during the in-processing procedures performed in FCI Ray Brook's receiving and discharge (R&D) area. FCI Ray Brook's policy prohibits disciplining inmates for refusing to answer or for not disclosing complete information during the screening process. A member of the inmate's unit team (case manager or counselor) screens all new arrivals within the first 72 hours of the inmate's arrival, but this activity ordinarily occurs on the day of arrival. The review of screening documents by the auditor confirmed that inmates identified at high risk for sexual victimization or at risk of sexually abusing other inmates were referred to a mental health professional and all received further assessment. Staff members also conduct screenings by reviewing

records or supportive information from other facilities. A unit team member reviews all relevant information received from other facilities and continues to reassess an inmate's risk level within 30 days of his arrival. Information received during the screening process is deemed confidential and only available to staff with a need-to-know and never to other inmates. Specialized and random staff interviews, a review of relevant documentation, such as the BOP Screening Form and the PREA Intake Screening Objective Instrument, and observations of the intake process confirm the facility's compliance with Standard 115.41.

The agency (through a committee) decides whether to assign a transgender or intersex inmate to a facility for male or female inmates.

FCI Ray Brook's policy states that a transgender or intersex inmate's own view with respect to his own safety is given serious consideration when making program or housing assignments. FCI Ray Brook determines appropriate housing and programming assignments for transgender or intersex inmates on a case-by-case basis and careful deliberation is given to all assignments. The Associate Warden/PREA Compliance Manager confirmed that housing and program assignment considerations include whether a placement would ensure the inmate's health and safety and whether the placement would present management or security problems.

Staff interviews and supporting documentation indicated that medical and mental health personnel meet on a regular basis to assess the status of any inmate thought to be at risk for victimization or inmates that are exhibiting institutional adjustment problems. The interview with the facility Associate Warden/PREA Compliance Manager also confirmed that a transgender inmate's genital status is not the sole criteria for placement in a specific facility. Placement and programming assignments for each transgender or intersex inmate would be reassessed at least once every six months. The Associate Warden/PREA Compliance Manager also indicated that transgender and intersex inmates housed at FCI Ray Brook would be given the opportunity to shower, dress and use toilet facilities separately from other inmates. Interviews with 30 inmates including ten (10) Limited English Proficient (LEP) inmates confirmed that all inmates could shower privately.

During the on-site tour, the auditor noticed that some cells in a housing unit did not provide privacy for all inmates when using the toilet or changing clothes. The issues of privacy noted by the auditor were corrected by the Associate Warden/PREA Compliance Manager before the on-site audit concluded.

Interviews with staff, an examination of documentation/policy and the BOP's over-site confirmed that FCI Ray Brook follows the requirements outlined in Standard 115.42.

Interviews with SHU officers and the SHU Lieutenant confirmed that, to the extent possible, access to programs, privileges, education and work opportunities are not limited to inmates placed in the SHU for the purposes of protective custody, except when there are safety concerns. FCI Ray Brook would document the reason for restricting access and the length of time the restriction would last. Mental health and unit staff meet with each inmate placed in SHU status at least weekly. A Safeguarding of Inmates Alleging Sexual Abuse/Assault Allegation Form is completed, when applicable, to document all appropriate alternatives for safeguarding inmate victims. Interviews with staff (random and specialized) during the on-site audit and an examination of documentation confirm staff's understanding of Standard 115.43. During the audit period, no inmate at risk for victimization was placed in the SHU. During the on-site audit, a tour of the SHU, informal interviews with SHU inmates and the SHU logbook documentation confirm the facility's compliance with Standard 115.43.

PS 5324.12, IS 5324.12(b), the Admission and Orientation Handbook and PREA postings address the requirements of Standard 115.51. A review of documentation indicated that there are multiple ways (including verbally, in writing, privately, from a third party and anonymously) for inmates to internally report sexual abuse or sexual harassment. Inmates (random and targeted) confirmed that they are informed about the reporting methods through the A&O Handbook and various PREA notices displayed on bulletin boards located in each housing unit and common area. Inmates also have access to TRULINCS, a computer program system which also provides PREA information and other internal reporting mechanisms. Through TRULINCS, the inmate can contact the Office of the Inspector General anonymously and the email is untraceable at the institution level. A sufficient number of TRULINCS computers and phones were observed in each housing unit at FCI Ray Brook. All staff (random and specialized) interviewed affirmed they would accept reports of sexual abuse/sexual harassment from inmates made verbally, in writing, anonymously and from third parties. In addition, the same staff confirmed that they would promptly document any form of reporting and immediately notify their superior while keeping the inmate safe. Program Statement 5324.12 requires all staff to immediately document any allegation.

Family and friends of inmates may report sexual abuse/sexual harassment by using the BOP website, making a phone call to the OIG or contacting facility staff. All inmates sampled during the on-site audit confirmed that they were aware of multiple methods of how to internally report sexual abuse/assault allegations. Inmates at FCI Ray Brook are not detained solely for civil immigration purposes. Interviews with staff and an examination of documentation also confirmed the facility's compliance with Standard 115.51.

PS 1330.18, Administrative Remedy Program, addresses the requirements of Standard 115.52. Grievances (administrative remedies) filed alleging sexual abuse/sexual harassment would result in the immediate opening of a formal investigation. The BOP policy states that there is no time limit for filing a grievance relating to sexual abuse or sexual harassment. Additionally, policy does not require an inmate to use any informal grievance process before filing an allegation involving sexual abuse/sexual harassment. A section of the inmate A&O Handbook was in conflict with BOP Program Statement 1330.18, Administrative Remedy Program. At best the handbook was unclear and compelled inmates to use the informal grievance process to resolve a PREA related administrative remedy (grievance). FCI Ray Brook, in practice, re-routes PREA related grievances to Special Investigative Services for investigation. Because the facility identifies the inmate handbook as a resource and mechanism to educate inmates about sexual abusive behaviors and how to report incidents of sexual abuse and sexual harassment, the handbook should be accurate and eliminate conflicting language. Prior to the conclusion of the on-site audit, FCI Ray Brook staff revised the inmate handbook to reflect the exact language outlined in PS 1330.18, which complies with Standard 115. 52, section a-g.

Allegations of physical abuse by staff shall be referred to the Office of Internal Affairs (OIA) in accordance with procedures established for such referrals. PS 1330.18 addresses the filing of emergency administrative remedy requests. If an inmate files the emergency grievance with the institution and believes he/she is under a substantial risk of imminent sexual abuse, an expedited response is required by the BOP within 48 hours. The BOP's program statement supported Standard 115.52; however, the A&O Handbook, contradicted PS 1330.18 the response must be made as soon as possible, usually within seventy-two (72) hours from receipt of the complaint. Prior to the conclusion of the on-site audit, FCI Ray Brook staff revised the inmate handbook to reflect the exact language outlined in PS 1330.18, which complies with Standard 115. 52.

There is no prohibition that limits third parties, including fellow inmates, staff members, family members, attorneys and outside advocates, in assisting inmates in filing requests for grievances relating to allegations of sexual abuse or filing such requests on behalf of inmates. A review of documentation related to grievances indicated there were zero grievances alleging sexual abuse/sexual harassment filed within the last twelve months that resulted in disciplinary action by FCI Ray Brook. Interviews with random staff and inmates confirm FCI Ray Brook's compliance with Standard 115.52.

PS 5324.12 addresses the requirements of Standard 115.53. The facility does not detain inmates solely for civil immigration purposes. FCI Ray Brook has made numerous attempts to enter into a service agreement with a local victim advocate organization to provide outside emotional support services to victims of sexual abuse. Email communication between the local crisis center and FCI Ray

Brook confirmed that the facility has made numerous attempts to obtain a service agreement for victims of sexual abuse/sexual harassment. However, as needed, the outside victim advocate organization continues to provide victim advocacy services to the facility. Inmates also have access to the National Sexual Assault Hotline. Facility staff members, to include mental health treatment providers, have also been trained as victim advocates.

FCI Ray Brook provides inmates with the telephone number and address to a community crisis counseling service to use following an allegation of sexual assault. Inmates are also advised to add the number to their calling list to facilitate the call from the inmate housing unit. Inmates are informed, as part of their orientation process, that all telephone calls (except properly placed legal calls) are subject to monitoring and recording and that all mail (except for legal mail) is subject to monitoring as well. Inmates are informed that emails to the Office of the Inspector General through TRULINCS - Request to Staff tab and selecting the Department Mailbox titled DOJ Sexual Abuse are not monitored by the facility or BOP.

Postings in the housing units and common areas, the PREA pamphlet issued upon the inmate's arrival and the A&O Handbook provide the address to the OIG and explain that inmates may confidentially submit written allegations of sexual abuse/sexual harassment to this entity. FCI Ray Brook enables reasonable communication between inmates and these organizations and agencies in as confidential a manner as possible. On-site audit interviews with random staff and inmates confirm the facility's compliance with Standard 115.53.

The BOP pamphlet "Sexually Abusive Behavior Prevention and Intervention", the Admission and Orientation Handbook, PREA posters throughout the facility, the posted Office of Inspector General address and the BOP website www.bop.gov address the requirement of the standard. The website and posted notices located in all housing units and the visiting room inform third party reporters on how to report allegations of sexual abuse/sexual harassment. During the on-site audit, interviews with random staff and inmates confirmed that both have a sufficient understanding that anonymous and third-party reporting procedures are acceptable sexual abuse/sexual harassment reporting practices at FCI Ray Brook. On-site audit interviews with random staff and inmates confirm the facility's compliance with Standard 115.54.

Policy requires that information concerning the identity of the alleged inmate victim and the specific facts of the case be limited to staff who need-to-know to protect the victim and maintain the integrity of the investigative process. Interviews with employees, contractors and volunteers confirmed that all were aware and understood their reporting duties and responsibilities. Additional compliance with all aspects of Standard 115.61 was verified through document and policy review. It should be noted that FCI Ray Brook does not house inmates under the age of 18.

Random and specialized staff interviews confirmed they were aware of their responsibilities when they become aware or suspect that an inmate is being or has been sexually abused or sexually harassed. Both random and specialized staff interviewed indicated they would act immediately to protect the inmate by separating and protecting the victim from the abuser, isolate the area (as a potential crime scene to preserve evidence) where the act allegedly occurred and would call the Shift Lieutenant for assistance. When notified, the interviewed Shift Lieutenants stated they would further protect the victim, notify medical and mental health staff and advise the Institution Duty Officer of the incident. In the past 12 months, there were no instances in which the facility staff determined that an inmate was subject to a substantial risk of imminent sexual abuse. Interviews with staff and an examination of documentation confirm the facility's compliance to Standard 115.62. FCI Ray Brook's documentation confirmed that, in the last 12 months, there were zero determinations made that an inmate was subjected to a substantial risk of imminent sexual abuse.

She indicated that the Warden at the inmate's current facility is required to notify the Warden of the previous facility and an investigation is initiated. When an inmate reports sexual abuse/sexual harassment from state, non-Bureau privatized facilities, jails, juvenile facilities and Residential Reentry Centers (halfway houses), the Warden contacts the appropriate office of the facility and/or notifies the Privatization Management or Residential Reentry Management Branch of the BOP, if appropriate. The notification is to occur as soon as possible, but within 72 hours of receiving the allegation.

In the past twelve (12) months, FCI Ray Brook received zero allegations that an inmate was sexually abused while confined at another facility. If such an incident were to occur, the Warden explained that she would document the incident and notify the head of the facility where the sexual abuse was alleged to have occurred. Interviews with the Associate Warden/PREA Compliance Manager and SIA confirmed that the inmate's previous facility would be made aware of the inmate's allegation of sexual abuse/sexual harassment and an investigation would be initiated. Upper management staff interviewed, to include the Warden, SIA, Associate Warden/PREA Compliance Manager and Captain, also confirm that each manager understood the notification and documentation requirements for complying with Standard 115.63.

All staff (random and specialized) interviewed, during the on-site audit, indicated they would separate the inmates, secure the area as a crime scene, not allow inmates to destroy any physical evidence and contact the Shift Lieutenant. The Shift Lieutenant confirmed, during his interview, that he would continue to protect the inmate and notify medical and mental health staff, the Emergency Response Team and members of the executive staff. Within the last year, there were zero incidents requiring security staff only to act as a first responder to an allegation of sexual abuse/sexual harassment. Interviews with staff (random and specialized) and an examination of documentation confirm the facility's compliance with Standard 115.64.

The Collective Bargaining Agreement (CBA), Memorandum of Certification, between the Federal Bureau of Prisons and Council of Prison Locals, American Federation of Government Employees, dated July 21, 2014-July 20, 2017, was examined by the auditor and found to comply with Standard 115.66. The agreement does not limit the agency's ability to remove alleged staff sexual abusers from contact with any inmates pending the outcome of an investigation or of a determination of whether and to what extent discipline is warranted. The auditor was advised that the CBA is currently being renegotiated and will contain the required language in its final form.

During the on-site interview, the Chief of Psychology Services confirmed that she would document and follow-up on all potential cases of retaliation to ensure policy is being enforced. In addition, the Chief of Psychology Services confirmed that she would conduct frequent periodic status checks on the inmate or staff member, monitor incident reports, housing reassignments and negative performance reviews/staff job reassignments for up to 90 days. If there was still a concern that there was a potential for possible retaliation, the Chief of Psychology Services indicated she would monitor the situation indefinitely. According to the Chief of Psychology Services, there have been no suspected or actual incidents of retaliation in the last 12 months. Facility compliance with Standard 115.67 was determined by a review of policy, staff interviews (random and specialized), to include the PREA Compliance Manager.

The Warden and the Chief of Psychology Services both confirmed that staff must first consider other alternatives based on the circumstances of the allegation before considering the placement an inmate in protective custody (SHU), placing him in another housing unit or transferring the inmate to another federal correctional facility. To aid in that decision, the agency and FCI Ray Brook's policy requires the facility to complete the BOP's Safeguarding of Inmates Alleging Sexual Abuse/Assault Allegation Form. The form serves to document consideration of all options. Interviews with staff and the tour of the facility confirmed that there are usually viable alternatives to placing victims of sexual abuse/sexual harassment in involuntary segregated housing (SHU). Staff members consider separate housing of the victim/predator, to include transfer of the inmates. To the

extent possible, access to programs, privileges, education and work opportunities are not limited to inmates placed in a SHU for the purposes of protective custody. The facility would document the reasons for restricting access and the length of time the restrictions would last. There were zero inmates placed in post-allegation protective custody status within the last twelve months. Compliance with this standard was determined by a review of policy during the on-site audit, SHU documentation and staff interviews, coupled with a memorandum from the Warden, validating involuntary segregation was not utilized to separate inmate victims from their abuser during the review period.

The facility's investigators (SIS) conduct administrative investigations within the facility and were interviewed by the auditor. When an allegation appears to be criminal in nature, the SIS, in conjunction with the BOP's Office of Internal Affairs and the facility Warden, will refer the incident to the FBI for a criminal investigation, if the investigation involves an inmate-on-inmate allegation. Staff-on-inmate criminal investigations are conducted by the Office of the Inspector General. The FBI or OIG consults with the Assistant U.S. Attorney when necessary. If the FBI or OIG substantiates the allegation, the case is referred to the local United States Attorney for possible prosecution. During the current auditing period, there were zero reported allegations of sexual abuse/sexual harassment. The number of sustained allegations of conduct that appeared to be criminal and that were referred for prosecution, since the last PREA audit, was zero according to the SIA. The SIA and the PREA Compliance Manager, during separate interviews, confirmed that all written reports associated with an administrative or criminal investigation of alleged sexual assault or sexual harassment would be retained by FCI Ray Brook for as long as the alleged abuser is incarcerated or employed by the BOP, plus five years.

The agency does not require an inmate who alleges sexual abuse to submit to a polygraph examination or other truth assessment device as a condition for proceeding with the investigation of such an allegation. Compliance with Standard 115.71 was determined by a review of PS 5324.12 and interviews with the SIA and the PREA Compliance Manager.

A review of investigative documentation confirmed the above statement. Local policy requires that inmates are informed in writing of the results of a PREA investigation. The PREA Compliance Manager indicated, during her interview, that when the allegation involves staff, the inmate would be informed if the staff member is no longer posted within their housing unit or is no longer employed at this facility, if the staff member was indicted on a charge related to sexual abuse within the facility or the agency learned that the staff member was convicted on a charge related to sexual abuse within its facilities. There have been no cases of inmates engaging in sexual activity with staff in the last twelve months. The Collective Bargaining Agreement (examined by auditor) between the Federal Bureau of Prisons and Council of Prison Locals, American Federation of Government Employees, dated July 21, 2014-July 20, 2017, allows for disciplinary sanctions against staff, including termination, for the sexual abuse or sexual harassment of an inmate. During her interview, the Human Resource Manager confirmed that all terminations for violations of agency sexual abuse or sexual harassment policies, or resignations by staff who would have been terminated if not for their resignation, may be reported to criminal investigators and to any relevant professional/certifying/licensing bodies by the agency, unless the activity was clearly not criminal. In the past 12-month period, FCI Ray Brook documented zero disciplinary sanctions against staff for violating the agency's sexual abuse or sexual harassment policies. A review of supporting documentation, to include a sample of sixteen (16) terminations and resignations, as well as staff interviews, confirm the facility's compliance with this standard.

The Inmate Discipline Program defines sexual assault of any person, involving non-consensual touching by force or threat of force, as the greatest severity level prohibited act. The program identifies inmates engaging in sexual acts and making sexual proposals or threats to another as a high severity level prohibited act. Consensual sex or sexual harassment of any nature is prohibited and will result in discipline. Consensual sex between inmates does not constitute sexual abuse. Sanctions are commensurate with the nature and circumstances of the abuse committed, the inmate's disciplinary history and the sanctions imposed for comparable offenses by other inmates with similar histories. Inmates are subject to disciplinary sanctions pursuant to the formal disciplinary process defined in the Inmate Discipline Program. The BOP does not discipline inmates who make an allegation in good faith, even if an investigation does not establish evidence sufficient to substantiate the allegation. Interviews with SIS investigators supported the facility's compliance. The Chief of Psychology Services confirmed, during her interview, that the disciplinary process considers whether an inmate's mental disabilities or mental illness contributed to the inmate's behavior when determining what type of sanction, if any, should be imposed. In addition, the Chief of Psychology Services indicated that, if mental disabilities or mental illness is a factor, the facility considers the offer of therapy, counseling or other interventions designed to address and correct underlying reasons or motivations for the abuse. Facility compliance with this standard was determined by a review of the facility and BOP policies and documentation, an interview with staff, to include the Chief of Psychology Services and SIS Investigator, and random inmate interviews.

Interviews with medical, mental health and specialized staff also confirm the facility has a comprehensive system for collecting medical and mental health information relevant to the PREA and has the capacity to provide continued re-assessment and follow-up services. The review of Psychology Services' "Risk of Sexual Victimization" and "Risk of Sexual Abusiveness" Forms confirmed that inmates who disclosed prior victimization during screening were offered a follow-up screening with medical or mental health staff within fourteen days. The screening is usually completed on the same day or within three days. Treatment services are offered without financial cost to the inmate. As confirmed by observation and a review of intake screening documents, screening for prior sexual victimization in any setting is conducted by unit team staff during in-processing procedures. In-processing procedures also screen for previous sexually assaultive behavior in an institutional setting or in the community. When indicated, inmates are offered a follow-up meeting with a mental health practitioner within fourteen days of the intake screening. Information related to sexual victimization or abusiveness is limited to medical and mental health practitioners and other staff with a need-to-know for the purpose of determining treatment plans, security, housing, work, program assignments and management decisions. Signed and dated informed consents are obtained from inmates before reporting prior sexual victimization that did not occur in an institutional setting. FCI Ray Brook does not house inmates under the age of 18 or females. Facility compliance with Standard 115.81 was determined by a review of policy and documentation and staff and inmate interviews.

Medical personnel are on duty 16 hours a day, seven days a week and are available for consultation or call-back on off hours. Mental health providers are on-site five days per week and are also available for call-back on off hours. Inmate victims of sexual abuse receive timely, unimpeded access to emergency medical/mental health treatment and crisis intervention services within the facility or are transported to a hospital in the community when health care needs exceed the level of care available within the institution. Victim advocacy is offered through community providers or trained staff members. There is no financial cost to the inmate for any sexual abuse/sexual harassment related incident medical or mental health care or advocacy service, regardless of whether the victim names the abuser or cooperates with the incident investigation. Inmate victims of sexual abuse while incarcerated are offered information about and timely access to information on sexually transmitted infection prophylaxis in accordance with professionally accepted standards of care, where medically appropriate. There were zero allegations of sexual abuse that required referral for forensic evidence collection by a SANE in the last year. Facility compliance with this standard was determined by a review of policy and documentation, as well as interviews with a Sexual Assault Nurse Examiner, a community victim advocate and specialized medical and mental health staff.

Inmates are also re-evaluated within 30 days of admission to the facility. The evaluation and treatment of such victims includes follow-up services. The facility would arrange for referrals for continued care following their transfer to or placement in other facilities or after their release from custody. The facility has fully staffed medical and mental health departments and offer sexual abuse/sexual harassment victims with medical and mental health services consistent with the standard of care available in the community. Inmate victims, while incarcerated, would be offered testing for sexually transmitted infections as medically appropriate. Administrative and/or criminal investigations are completed on all allegations of sexual abuse/sexual harassment. The facility investigators and/or the FBI/OIG/OIA conduct all investigations. Interviews with the SIS staff confirmed that they were knowledgeable concerning the requirements of the program and that they provided information to the Incident Review Team. The facility conducts a sexual abuse incident review at the end of every sexual abuse investigation unless the allegation was determined to be unfounded. The Incident Review Team consists of the Human Resource Manager, Chief of Psychology Services, Health Services Administrator, Unit Manager, SIA and other administrative staff. Based on interviews with members of the Incident Review Team, the review is conducted within 30 days of the conclusion of the investigation and consideration is given as to whether the incident was motivated by race, ethnicity, gender identity, and status or gang affiliation. The team also decides as to whether additional monitoring technology or staffing should be added to enhance inmate supervision. The facility implements the recommendations for improvement or documents its reasons for not doing so. There were zero allegations of sexual abuse/harassment during the audit review period. The auditor, through interviews with the SIS and SIA, determined that Incident Review Team would conduct an incident review within 30 days of the conclusion of all sexual abuse investigations unless the incident was determined to be unfounded.
