

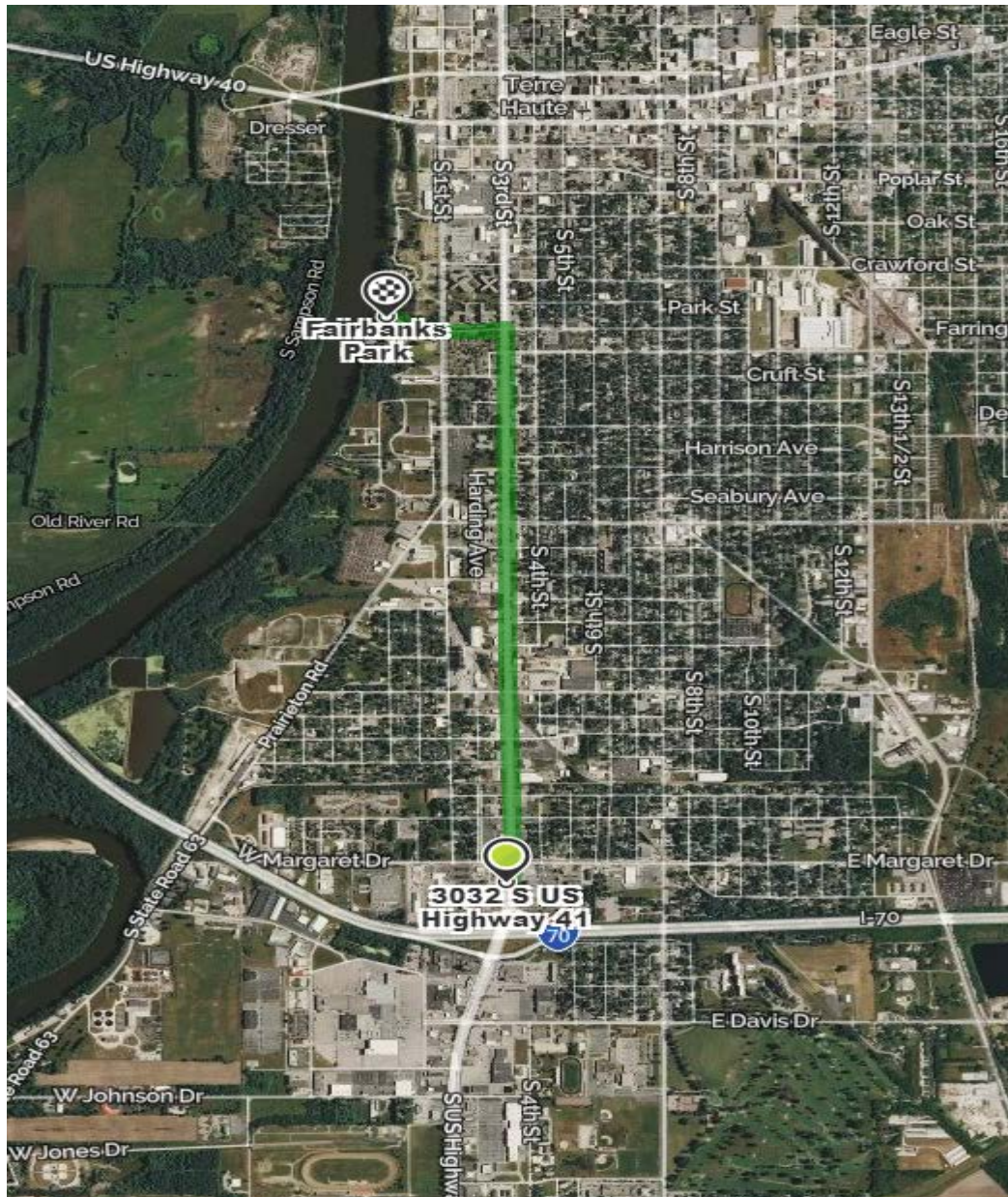

Information for Demonstrators

- In accordance with Federal Regulations, the Bureau of Prisons provides an opportunity for interested persons to exercise their First Amendment rights to demonstrate for or against capital punishment in a lawful manner and ensures a firm and adequate response to unlawful civil disobedience, trespass, or other violations of the law by persons attempting to disrupt or prevent the execution(s).
- On Tuesday, September 22, demonstrators **FOR** capital punishment can assemble at the Fairbanks Park for processing beginning at 2:00 pm and will be transported to FCC Terre Haute via bus. No demonstrators will be processed after 3:30 pm. On Thursday, September 24, demonstrators **FOR** capital punishment can assemble at the Fairbanks Park for processing beginning at 2:00 pm and will be transported to FCC Terre Haute via bus. No demonstrators will be processed after 3:30 pm.
- On Tuesday, September 22, demonstrators **AGAINST** capital punishment can assemble at MSA Softball for processing beginning at 2:00 pm and will be transported to FCC Terre Haute via bus. No demonstrators will be processed after 3:30 pm. On Thursday, September 24, demonstrators **AGAINST** capital punishment can assemble at MSA Softball for processing beginning at 2:00 pm and will be transported to FCC Terre Haute via bus. No demonstrators will be processed after 3:30 pm.
- Approved items for demonstrators are as follows and are the ONLY items that will be allowed in the demonstrator areas:
 - A Book, Hymnal or any other type of religious book
 - Rosary or Religious Medallion
 - Candle and Wind Shield
 - One book of matches
 - Car Keys
 - Photo I.D.
 - Necessary Medication
 - A Sign made of paper card board or Linen that can be carried on the bus.
 - No Signs made of Wood, Metal, or Pole Supports
 - Water and a Seating Area will be provided
 - ABSOLUTELY no cell phones or recording devices
- All demonstrators will be issued a face mask upon arrival and will be required to wear it throughout the entire process. Demonstrators will be subject to COVID-19 screening in accordance with published CDC guidelines to include a temperature check. To the extent practical, social distancing of 6 feet should be exercised. Demonstrators must understand that any violation will subject them to immediate removal from the premises.

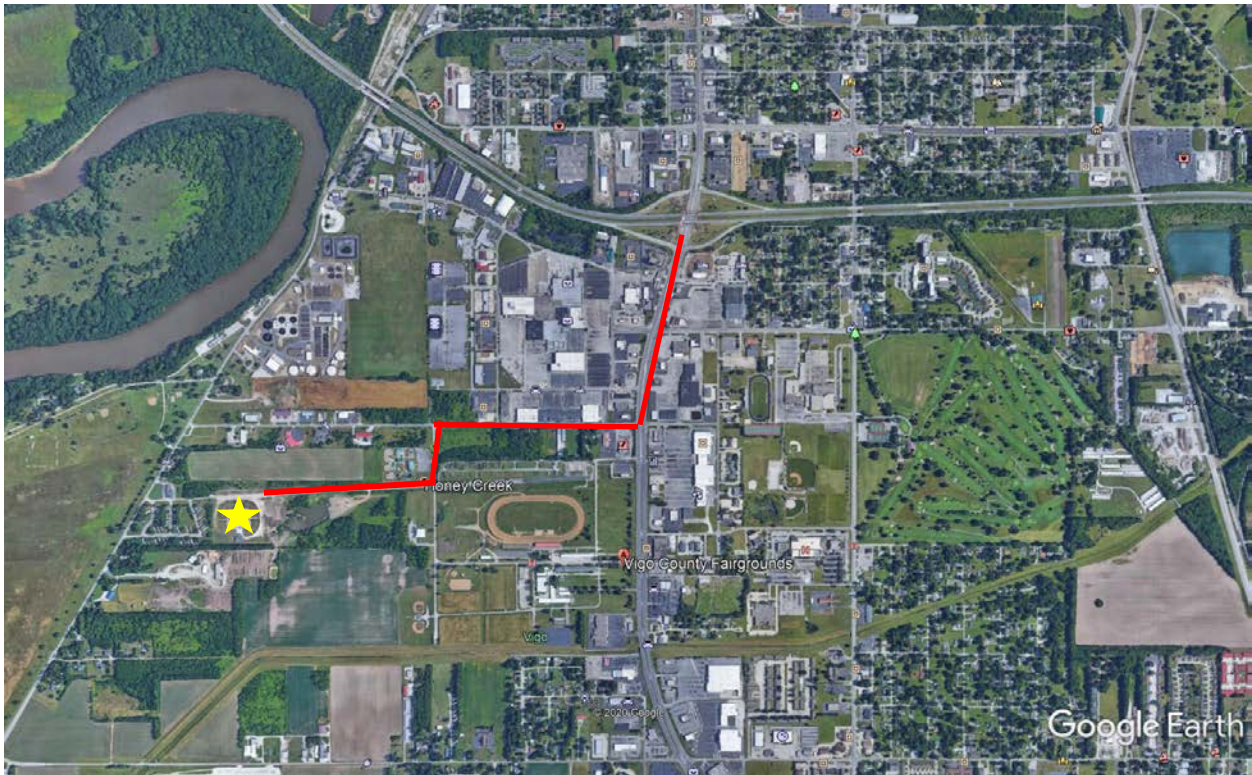
Demonstrators **FOR** capital punishment can assemble at Fairbanks Park



From I-70 to Fairbanks Park

- North on U.S. Hwy 41 (1.6 Miles)
- Turn left (West) onto Farrington St.
- Farrington St. becomes Dresser Dr. (0.3 Miles)
- Turn left onto Girl Scout Lane (.01 Miles)

Demonstrators **AGAINST** capital punishment can assemble at MSA Softball



From I-70 (Exit 7) to MSA Softball

- South on U.S. Hwy 41 to Johnson Dr. (0.5 Miles)
- Right on Johnson Dr. to Union Rd. (0.48 Miles)
- Union Rd to Fairgrounds Dr. (0.14 Miles)
- Left on West Jones Drive (.46 Miles)
